Eligibility Requirements

- Open to PFCU primary account holders. Membership must be established on or before application deadline and remain open until PFCU's annual meeting date.
- 2. Applicant must be pursuing secondary education at an accredited 4-year, 2-year or technical school in the 2025 2026 school year.
- 3. Student must have a cumulative grade point average of 3.0 or above on a 4.0 point scale at the end of the first semester.
- 4. Must be a Class of 2025 graduating high school senior.
- 5. Recipients will participate in an award ceremony at the Annual Meeting and/or provide a photo for media use.
- 6. Application along with supporting documents must be complete, signed and returned to any PFCU branches by **March 31, 2025**. Applications may be emailed to **marketing@primefcu.org** or mailed to:

- Recipients will be notified beginning April 30, 2025, via email and/or mail.
- Award will be disbursed on the day of PFCU's annual meeting.
- Incomplete submissions may result in disqualification.

2. Disclosure & Media Form – Parent/guardian signature needed if you are under 18 years old.				
3. Letter of Recommendation – Letter, with a signature, must be from a non-relative describing why you should receive this scholarship. We highly recommend education/business related letters to be printed on letterhead.				
4. Official Transcript – Transcript must include the name of the high school you are attending, your anticipated graduation date and cumulative GPA at the end of the first semester.				
 5. Personal Essay (Maximum 2 page, 12-point font, double space) – Your essay must address the following topics: 1) Your academic, career or personal goals 2) Your contributions to your community such as volunteer work, assistance in community programs, etc. 3) How you plan to make a difference with your education 				
6. Proof of Acceptance/Enrollment - Copy of acceptance email/letter or Proof of Enrollment
